Payment Policies and Procedures

1. There is a non-refundable activity fee of \$20.00 per child. This fee is due and payable at the time this Registration and Financial Agreement is submitted. Full rate applies regardless of amount of time spent at KNO. There are no discounts for early pickup or for multiple children.
2. Kids Night Out positions will be filled on a first-come, first-serve basis, with early registration for Before/After Care families. Capacity is limited. Submissions in excess of capacity will be returned and refunded.
3. Students must adhere to all district and school policies, as well as federal, state and local laws. Disciplinary action at KNO will follow the FHM policies for behavior response. Parent/guardian will be required to immediately pick up any child who is unable to adhere to the above, and no refund will be given.

Drop-Off / Pick-Up Procedures:

Students will be dropped off in the front entryway at FHM and signed in by a parent/guardian. Students continuing in care from After Care will be signed in by the After Care staff. Pick up hour will be 9:30-10pm from the movie rooms, or the front lobby after the movie.

Late Pick-Up Fees / Procedures

If your child is not picked-up by the end of activity hours (10:00 PM), the teacher on duty will be required to stay. A late fee of **\$1.00 per minute** will be charged and a check payable to FHM for the full fee amount must be given to staff on duty. If the child is not picked-up within 60 minutes of closing and/or the parents/guardians cannot be reached, the Jefferson County Sheriff’s department will be notified and the child will be released into the custody of Social Services.
