Open Enrollment in Charter Schools

Enrollment in a charter school is a choice enrollment under Jeffco School Board Policy JFBA and Regulation JFBA-R. Under the choice enrollment policy, a student who is accepted into the school is accepted for the span of grades of that school, and is not required to reapply each year for admittance. The school in which the open enrolled student is admitted becomes the "home" school of the student for the span of grades of that school. Should a parent and student wish to return to their neighborhood public school, they would have to apply to the neighborhood school for admittance. If the neighborhood school has "space available" (classroom space and teaching staff) in the requested program, and the student meets the applicable program entrance requirements, such as age requirements, the application would be approved and the child would be admitted. If the student is not admitted, the student would continue to be enrolled at the charter school.
